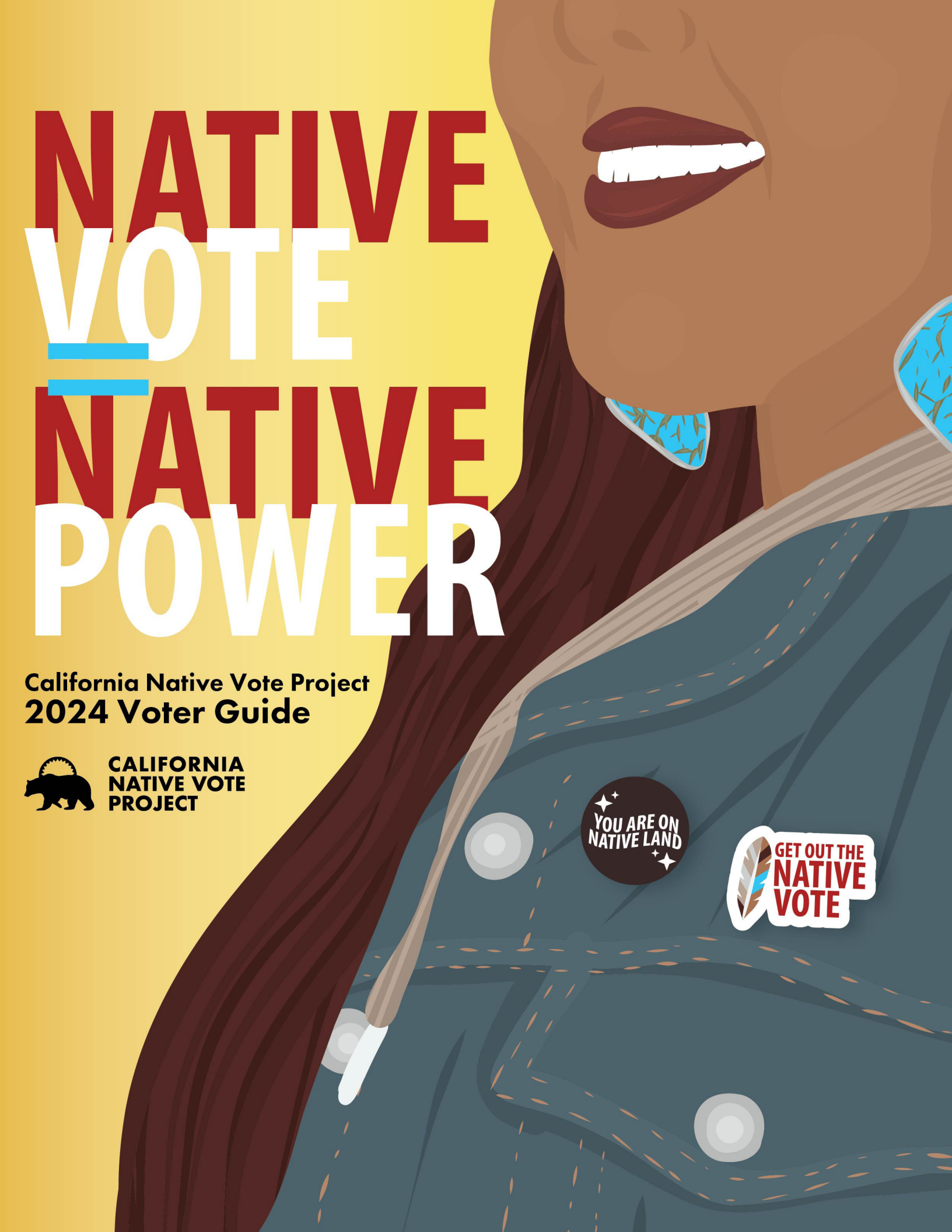

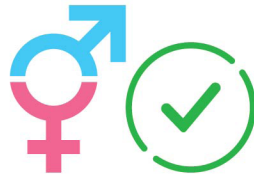




**YES ON PROP 2**

**Education facilities improvement**

Bond issuance of \$10 billion to fund school construction and modernization. \$8.5 billion would be allocated to K-12 buildings, the remaining \$1.5 billion earmarked for community colleges.



**YES ON PROP 3**

**Marriage equality**

Reaffirms the right of same-sex marriage. Repeals definition in the state constitution that specifies the right to marriage between a man and woman. The new definition declares marriage to be a fundamental right.



**YES ON PROP 4**

**Climate protection**

\$10 billion bond to offset budget cuts and fund state and local parks, climate programs, water infrastructure projects, energy projects, and flood protection projects.



**YES ON 5**

**Housing & infrastructure bonds**

Constitutional amendment that would lower the vote threshold required for local bond measures to fund housing projects and public infrastructure, making it easier for local governments to borrow money for affordable housing and other infrastructure.



**YES ON PROP 6**

**Ending slavery in prison**

Limit forced labor and indentured servitude in state prisons, considered one of the last remnants of slavery. The California Black Legislative Caucus included the amendment in its reparations bill package.







**YES ON PROP 32**

**Minimum wage**

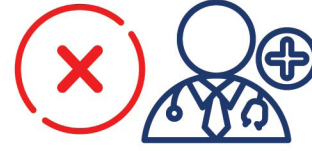
Incrementally increases minimum wage until it reaches \$18 per hour on January 1, 2026. However, in the event of an economic downturn, the Governor has the authority to suspend the increase twice, which could delay the target date.



**YES ON PROP 33**

**Justice for renters**

Expand rent control and repeal the Costa Hawkins Rental Housing Act, which has banned rent control on single-family homes built after 1995. It would prohibit the state from limiting the rights of cities and counties to maintain, enact, or expand rent control ordinances.



**NO ON PROP 34**

**Patient spending**

Requires health care providers to spend 98 percent of revenues from federal discount prescription drug programs on patient care. This measure takes aim at groups like the AIDS Healthcare Foundation, which has been active in funding ballot measures.



**YES ON PROP 35**

**Medi-Cal funding**

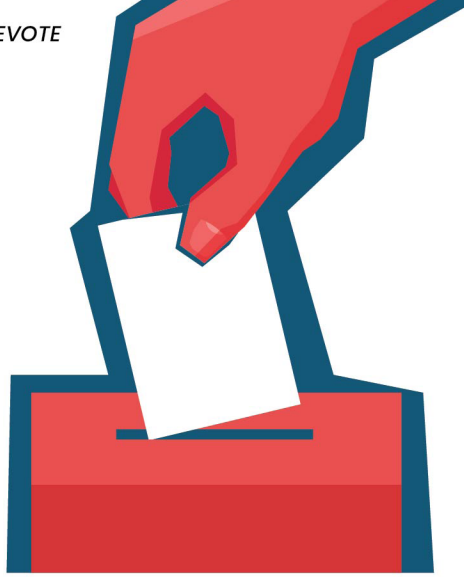
State must spend money from a health care plan tax on Medi-Cal program, increasing access and equity. Legislators would not be allowed to use the tax revenue to replace existing state Medi-Cal spending.



**NO ON PROP 36**

**Drug and theft crime penalties**

Would increase penalties for some theft and drug crimes from misdemeanors to felonies. Would require people who sell large quantities of certain drugs, including fentanyl-based substances, to serve their term in state prison. A "treatment based felony," would be created for people who don't contest charges and choose to complete drug treatment in lieu of prison. If treatment isn't completed, they could still face up to three years in prison.



## FOLLOW **THESE STEPS** TO VOTE BY MAIL

### SEAL IT.

Secure your ballot inside the envelope from your county elections office.

### SIGN IT.

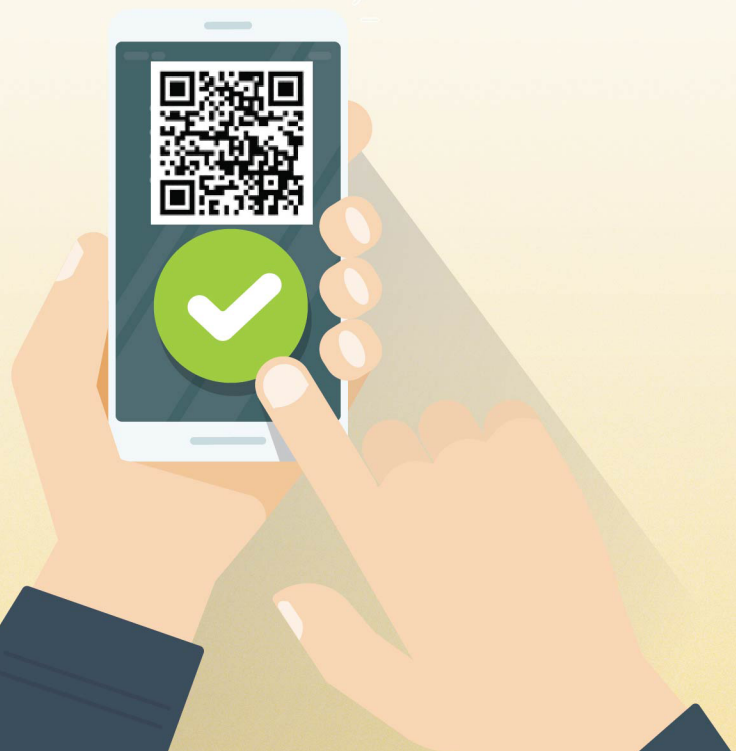
Make sure the signature on your ballot envelope matches the one on your CA driver license/state ID, or the one you provided when registering. Your county elections office will compare them to protect your vote.

### RETURN IT.

By mail – make sure your ballot is postmarked by November 5, 2024. NO STAMP REQUIRED. OR in person – drop your ballot off at a secure drop box, polling place, vote center, or county elections office by 8 pm on November 5, 2024.

### TRACK IT.

## CREATING A **PLAN TO VOTE** IS KEY HERE ARE SOME OF YOUR OPTIONS

### **BY MAIL**

Mail in your signed ballot to your local election offices. No stamp is required. Mail it out early and postmarked on or before Election Day, November 5, 2024.

### **DROP OFF**

You can drop off your ballot at your local elections office or at any ballot drop box, polling place, or vote center.

### **IN PERSON**

You can vote in person at your local polling place, vote center, or county elections office. Your polling place will be listed on the sample ballot you receive in the mail and on your county election office's website.
