Your use of any of the Services signifies your agreement to the terms and conditions of this Privacy Policy.

Who Should Use the Services

The services are not directed at, marketed to, or intended for users under the the age of 13. We do not and will not knowingly or intentionally collect any information from children under the age of 13 years of age. If we learn that any information was provided to the Coalition through any of the Services by a user younger than 13 years of age, we will delete the information immediately.

the Coalition values and respects an individual's right to keep certain personal information private. Likewise, The Coalition values the need to collect and use Personal Information which will enable the Coalition to effectively deliver products and services. This Privacy Policy applies to persons visiting the Coalition website, signing up for Coalition publications and mailings, or entering into transactions with the Coalition, and covers the collection, use, storage and disclosures of information and data as described in this Privacy Policy.

The Coalition will not sell your personal information.

The Coalition reserves the right to disclose all information if (a) required by law, regulation, legal process, or enforceable governmental request, (b) enforce the applicable <u>Terms of Service</u>, including any investigations of potential violations, (c) resolve any potential disputes or security and/or technical issues, and (d) protect the rights, property and safety of the Coalition, its users, or the public as required or permitted by the law.

The Coalition will make every effort to discontinue the use of an individual's personal information as soon as possible if requested by that individual. The Coalition may need to retain information in its archives and records for the aforementioned reasons.

1. Administrative

a. the Coalition will take reasonable and appropriate measures to keep Personal Information confidential and in a secure environment, including taking appropriate action in the event of unauthorized disclosure and also including internal reviews of the Coalition's data collection, storage, and processing practices and security measures, as well as physical security measures to guard against unauthorized access to systems where personal data is stored.

- b. Access to Personal Information will be restricted to those personnel with a legitimate business purpose.
- c. the Coalition owns all Personal Information provided to it by individuals and collected in accordance with this Privacy Policy.
- d. When an individual uses the Choose Clean Water website and related products and services, upon request via the address below, the Coalition will provide the individual with access to their personal information to either to correct this data, if it is inaccurate, or delete such data.

- e. For disclosure of Demographic Information (e.g. organization the Coalition events, helping individuals connect offline at professional conferences, aggregation of data to advise future targeting, etc), the Coalition at a minimum will use the "opt out" approach. An "opt out" is obtained by the Coalition when through some correspondence gives an individual the opportunity to decline or "opt out" of disclosure to third parties. If the individual does not opt out, permission is deemed to have been granted. Depending on the nature of an activity or project, a higher standard than opt out may be used, such as "opt in" whereby an individual must affirmatively give consent before information may be disclosed.
- f. the Coalition sometimes engages third parties to provide certain operational services to the Coalition or on its behalf. the Coalition may disclose personal information to those third parties on a need to know basis under a written contract.
- g. The Coalition uses and allows third parties to use aggregate information for research purposes for the development or implementation of its programs, products, and services.

The Coalition has the individual's consent. the Coalition requires opt-in consent for the sharing of personal information.
