If you vote in person, you will deposit your sealed ballot into the ballot box and the Local Election Committee will later mail your sealed ballot to the American Arbitration Association post office box at the conclusion of all in-person balloting.

If you are unavailable to vote on the date and time above, you may request a replacement mail ballot by calling the office of the American Arbitration Association at 800-529-5218, or emailing [UlerioS@adr.org](mailto:UlerioS@adr.org).

To be counted, all mail ballots must be received in the AAA post office box by no later than 5 pm on Monday, December 9. If your replacement mail ballot is not received in the AAA post office box by December 9, 2019 it will not be counted.
