PHENOM Campus Chapter Initiative- In partnership with the Massachusetts Teachers Association (MTA) PHENOM provides stipends to MTA members and student organizers to build PHENOM Campus Chapters on several Public College Campuses across the state. These chapters engage the campus community in advocating for accessible, affordable, and well-funded public higher education through involvement in statewide and campus-based education, organizing, and advocacy.

PHENOM continued to build public support for better funded, more affordable and more accessible public higher education on and around public campuses across the state. This involved lectures, presentations to classes, meetings with campus and community organizations, letter-writing campaigns.

Throughout the year, PHENOM focused public attention on the need to understand and alleviate the student loan debt crisis.
