We know we deserve the same rights and benefits as those states and that's why we're forming a union in Oregon!

Medical interpreters in Washington formed their union in 2011. These are the wage increases they've won by having a union contract. This is why we're joining together and uniting in Oregon! There is strength in a union!

HOW WE WILL FORM OUR UNION

Last year we passed legislation...

Now as independent contractors we can form a union! Here's how we'll do it:

- Talk to medical interpreters across the state, see what issues are most important and what changes interpreters want to see in a contract with the state.
- 2. Medical Interpreters sign cards to form and join our union. Cards are confidential so your personal information will not be shared with agencies.
- 3. Once we reach a majority of certified and qualified interpreters signed up on union cards, we will file for recognition with the state of Oregon.
- 4.We're recognized as a union!
- 5. Send out surveys to all medical interpreters to prioritize our needs like raises, benefits, travel reimbursement, compensation for cancelled appointments, continuing education funds, etc.
- 6.Elect our bargaining committee. They will represent us at the bargaining table.
- 7. Begin negotiations with the state to create a legally binding contract that all agencies, hospitals, and clinics have to follow and abide by.
- 8.All union members vote on the contract.
- 9. If a majority votes yes, the contract will go into effect and we will have rights as medical interpreters!
- 10.Once a contract is decided, voted on, and ratified, we will be full-fledged, duespaying members of our union!
