"Connecticut is fortunate to have many candidates with a deep commitment to progressive values and climate justice," says CCAG Executive Director Tom Swan. "CCAG, and our thousands of member families, are pleased to work with these champions to continue our progress to a more just society.

"While we have made progress, much work remains on critical issues such as climate justice, affordable quality health care for all people, and full access to democracy," Swan added. "The climate crisis in particular becomes more urgent with each passing day."

This fall, in addition to issue and legislative work, CCAG is working on the Constitutional amendment on early voting, which will be on the November 8th ballot.

This term the legislature began to seriously address the challenges of climate change – but failed, for the most part, to limit the profiteering of the health insurance industry, which continues to extract massive profits at the expense of Connecticut families.
