January Digest ***Change Requires Action***



State Representatives of the Indiana House Committee on Courts & Criminal Code were given a copy of our [HMM brochure](#) at the initial hearing for HB1198 on Wednesday January 18th, 2023.

We're gearing up for an exciting year of change as HIV Modernization [HB1198](#) has been introduced this session!

2023 HB1198 HIV Modernization Overview

HB1198 removes 1980/90s sentence enhancements and criminal offenses related to HIV that were based on stigma and misinformation about people who are HIV positive. It adds '*intent to harm*' to existing punishment for people who engage in an act that can transmit HIV.

More specifically, this bill:

- Repeals offenses concerning the donation, sale, or transfer of blood products, or semen for artificial insemination in fertility care, that pose no risk of HIV transmission. *The FDA policy to destroy blood products that test positive for HIV remains in place.*
- Removes sentencing enhancements under the battery & malicious mischief by bodily fluid statutes for people with HIV. *People with HIV who violate the bodily fluids crime will still be punished, just not with enhancement.*
- Adds a “mens rea” intent to harm requirement to the HIV duty to inform law when engaging in high risk activity. *For the first time in Indiana, the law provides a way to fairly distinguish people who intended harm from those who did not. Maintains felony sentence enhancement for those who did intend harm.*

Where is our bill HB1198?!

HIV Modernization HB1198 was discussed at the January 18th hearing of the House Courts & Criminal Code committee with testimony in favor and against the bill. The committee will vote on an amended bill this Wed Jan 25 ([watch live here](#)). We are cautiously optimistic, based on the initial committee discussion. We will keep you informed.

The main bill sponsor this year is [Rep. Wendy McNamara \(HD76\)](#), who chaired the Interim Study Committee last year that discussed HIV modernization in depth. She is also the Chair of the House Courts & Criminal Code committee, where the bill is being initially discussed and voted on. Other bill sponsors include [Rep. Clere \(HD72\)](#), [Rep. Negele \(HD13\)](#), and [Rep. Vermilion \(HD31\)](#).

Get ready to contact your [district representative](#) later this and next week to ask for their YES vote. We will send more direction, with sample scripts, after we get through committee.
