The echoes with today are loud. I see people running to Turkish ports from Afghanistan, from Syria, from Somalia, crowding into rubber dinghies and pushing off, hoping to reach safety in Europe. I see children wading through the Rio Grande, clinging to a parent's hand, hoping only to make it to the other side. On our festival of freedom, let's mark our safety by working for the safety of everyone whose circumstances cause them to run.





## ACTIONS

### Act to Support the Afghan Adjustment Act

Dick and Carrie Stein, Jewish Coalition leaders and Temple B'nai Torah members, provided emergency temporary housing for three young Afghan men with humanitarian parole status in January of 2022. One stayed for six weeks, and they continue to provide support for him. It has been very hard even for these seasoned advocates to find him legal assistance to file an asylum application.

In a few months, his parole status will expire, and he will have no protection from deportation. He can't go back to Afghanistan. The Taliban have terrorized his family and beaten a family member twice, demanding to know his location. We owe him, and thousands of others, respect and protection from deportation. After fleeing violence and persecution – often because of their brave work in service of U.S. interests – Afghan evacuees deserve to live their lives in stability and safety, without the fears, limitations, and uncertainty that temporary immigration status entails.

1. **EMAIL:** [Send your Senators an email](#) urging them to cosponsor and support the Afghan Adjustment Act.
2. **CALL:** Call your Senators and ask them to grant Afghan evacuees a clear pathway to permanent residence by passing the Afghan Adjustment Act. Dial **202-224-3121** and a switchboard operator will help connect you directly to your Senators.
3. **GET SOCIAL:** Post on social media to share why you support the [Afghan Adjustment Act](#) and urge your friends to join you.

### **Accompaniment with Colectiva Legal del Pueblo: Asylum Pro Se Clinics**

**Want to support immigrant community members on their paths to asylum? Are you proficient in Spanish? Would you be available to support JCIJ's partner org, Colectiva Legal del Pueblo, at their upcoming Asylum Pro Se Clinics?** These clinics are offered to provide community members the opportunity to complete their Form I-589, Application for Asylum and Withholding of Removal, in a timely fashion, before their one year time limit runs out. Considering the huge demand for legal services, this can be a real worry for community members seeking asylum.

Colectiva requires that the accompaniment volunteers attend one Asylum Pro Se Clinic to shadow a legal team employee in order to learn how to fill out forms. The volunteers will be trained to assist clients to complete their Form I-589 in English. This process is straightforward since Colectiva asks clients to complete an intake packet in preparation for the clinic. Colectiva will then verify the volunteer's ability to work independently with attendees at the next Asylum

Pro Se Clinic with an attorney review of all work. Colectiva's legal team will be on hand to answer questions, work with clients with more complicated cases, and review volunteers' work.

**The next Colectiva Asylum Pro Se Clinic will be held on Saturday April 22, 2023 from 9:30am - 4:00pm at Colectiva's office, located at [13838 1st Avenue South](#), Second Floor, Burien, WA 98168.** Additional Asylum Pro Se Clinics are scheduled for August 19, 2023 and December 2, 2023.



## Advocacy

**Federal Immigration - Opposing the Biden Administration's Asylum Ban:** We reached out to 38 northwest rabbis, asking them to sign on to the HIAS clergy letter, which reads in part: *President Biden, we call on you as our president and as a fellow person of faith who believes in human dignity to withdraw the proposed asylum ban and institute a more just and compassionate system that reflects the best of America.* We also asked you to submit unique Public Comments opposing the proposed asylum ban, and many of you took action! Thank you!!

## JCIJ Book Club

## LEGISLATIVE SESSION UPDATE

### Unemployment for Undocumented Workers (HB 1095/SB 5109)

Unemployment Benefits for Undocumented Workers built a powerful base of co-sponsors and got the furthest it has gotten in passing out of the House and Senate Labor Committees. Unfortunately, it did not get a hearing in the House and Senate Budget Committees.

With budget constraints and concerns of the cost deemed too high (NOTE: Undocumented immigrant workers are already paying taxes without receiving benefits), we have our work cut out for us in the interim to build support and an even stronger shift in narrative. THANK YOU for taking action with JCIJ this year to move this bill! We will gear up for an even bigger fight next year.

### Budget Updates

Legislative Session goes until April 23rd, and the Senate and House released their budgets.

- Both budgets fund the DSHS Naturalization program at \$3.5M in both SFY 24 and 25 (a \$954,000 increase per year from current levels);
- Both budgets fund the WA New Americans program OneAmerica runs at \$2M in both fiscal years (a \$1M increase per year from current levels); and
- The Senate budget funds the Legal Support and Community Safety program at \$8M in both fiscal years (a \$4M increase per year from current levels), but the House budget does not provide an increase.
- Health Equity for Immigrants did not get sufficient funding.

## **States Lead the Way in Banning Immigration Detention Centers**

Bills attempting to ban certain immigration detention centers have been introduced in multiple states. Following the lead of states like [New Jersey](#) and [Illinois](#), New Mexico and Colorado have bills pending that would drastically decrease immigration detention with the hope that this would lead to an end of immigrant detention altogether in their states.

Ending immigrant detention by attacking it at the state level is a relatively new strategy by immigrant rights organizations. California was the first to enact a ban on some immigration detention centers in [2017](#). In 2019, California banned private, for-profit immigration detention centers. However, in 2022 this ban [was found](#) to be unconstitutional by the 9th Circuit Court of Appeals. Washington state's bill to end private detention closely mirrors California's bill and is expected to be challenged. [Read more](#). This article was shared by the American Immigration Council.

## **Florida Has Everything to Lose if it Repeals Instate Tuition for Undocumented Students**

In Florida, Gov. Ron DeSantis in his steady attacks on immigrants recently [announced](#) a legislative proposal that would eliminate in-state tuition for undocumented immigrant students, many of whom were brought to this country as small children and have only ever known Florida as home. This would double the cost of tuition causing further financial hardship in accessing higher education.

If in-state tuition for Dreamers and undocumented students is repealed, the economic consequences facing Florida are devastating. When Texas considered a similar proposal, the Council's research [showed](#) the state risked losses of \$213.6 million in wage earnings and \$184.2 million in spending power without these graduates. That's nearly \$400 million in lost economic activity in just one year. This article was shared by the American Immigration Council.
