AIDSWatch began 31 years ago with a small group of dedicated advocates and became the nation's largest, national, constituent-based HIV advocacy event. The tradition will continue March 17-19, 2024 in Washington, DC. **SAVE THE DATE!**

Each year AIDSWatch brings together hundreds of people living with HIV and their allies in Washington, D.C., to learn about the latest policy issues, messaging strategy and advocacy tactics. One of their [main policy priorities](#) in recent years has been HIV criminalization and modernization, including community input on molecular HIV surveillance.

Along with AIDSWatch, our specific federal ask on HIV modernization is to pass **The Repeal Existing Policies that Encourages and Allow Legal (REPEAL) HIV Criminalization Act** that is consistent with current HIV decriminalization advocates' understanding and strategy and incentivizes states to modernize or repeal their respective laws. When this comes up for a vote in Congress, we will send out an HMM Action Alert asking for your help!

- Register to vote
- Verify that your registration is active
- Find your polling place
- Apply for absentee (mail-in) ballot
- Preview your ballot

Voter Registration Deadline: Tuesday, October 10, 2023

Early Voting: Wednesday, October 11 - Monday, November 6 at noon

Absentee Applications Due: Monday, October 26, 11:59pm

Absentee Ballots Due: Tuesday, November 7, 2023, 6pm

Election Day: Tuesday, November 7, 2023, 6am-6pm

The 2023 elections are municipal elections. These elections occur every 4 years. This is when local government officials are elected, like mayor, clerk, treasurer, clerk-treasurer, city or town council, and city or town judge. The exact offices on your ballot depend on the size of the city or town you live in.

CRIMINAL RECORD? Formerly incarcerated, people with criminal records, people in jail awaiting trial, or people out on bail or parole can register to vote.

COLLEGE STUDENT? College students may register using their campus address.

RECENTLY MOVED? If you have lived at the address on your registration for at least 30 days, you can vote at your new residence.

ALMOST 18? If you will be 18 on or before Election Day (11/7) you can register to vote now.

UNHOUSED OR WITHOUT A PERMANENT ADDRESS? Use the mailing address of where you typically spend the night, or where you can receive mail when you

register.
