# From the Retirement Counselor's Pen

There have been recent changes to the "working after retirement" rules for retirees wishing to return to work for a Michigan public school, Michigan charter school, or a third-party providing services to a Michigan public school or Michigan charter school.

A retiree may collect their pension and receive healthcare insurance from ORS **and** return to work for a Michigan public school, Michigan charter school, or a third-party providing services to a Michigan public or charter school *immediately* after they retire as long as they do not earn more than \$15,100 in wages during the first six months following their retirement.

Example: If a person retires effective July 1, 2024, they can return to work immediately for any Michigan public school, Michigan charter school, or a third-party providing services to a Michigan public or charter school as long as they do not earn more than \$15,100 in wages during July through December (six months) of 2024. If they exceed \$15,100 in wages working for a Michigan public school, Michigan charter school, or a third-party providing services to a Michigan public or charter school during the first six months of their retirement, their pension and healthcare insurance from ORS will be suspended until they stop working.

Once a person has been retired for six months, they can continue to collect their pension and receive healthcare insurance from ORS and work for a Michigan public school, Michigan charter school, or a third-party providing services to a Michigan public or charter school and earn as much as the Michigan public or charter school, or third-party is willing to pay them. (There is no longer an earnings limit.)

The rules for working after retirement for a private school, or in private industry, or for a public or charter school in another state have not changed. A retiree may work for any of those entities immediately after they retire without an earnings limit and collect their pension and receive healthcare insurance from ORS.

It is important to note that if a person retires and begins collecting Social Security and is between the ages of 62 and 66\* to 67\* (\*it depends on the month and year of their birth), they will have an earnings limit of \$22,320 in 2024 on wages earned *no matter where they work*. (This earnings limit does not include the money received from their pension.) If they earn more than \$22,320 in wages, they will have pay back some, or all. of their Social Security.

### Adult Education




### Retirees Holiday Luncheon



#### **ABOUT YOUR RIGHTS**

If you are called to a meeting with management that you suspect will be disciplinary in nature you have the right to request union representation under the U. S. Supreme Court ruling, NLRB v. Weingarten.

If in a meeting with management you are questioned to obtain information and you have reasonable apprehension that your answers could be used as a basis for discipline or other adverse action, it is your responsibility to ask to reschedule the meeting or resume when your union representative is pres- ent. If you choose to remain you may refuse to answer.

If you are in a situation where Weingarten may apply, read or present the statement as outlined below:

#### WEINGARTEN RIGHTS

'If this interview could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union be present at this meeting. Until my representative arrives, I choose not to participate in this discussion.

**RESOLVING AN ISSUE:** If there is a contractual issue and you need assistance, reach out first to your building representative. If the issue is beyond the scope of the building rep's duties, then contact the Labor Relations Administrator who is assigned to your work location (see above email addresses).

**SEPARATION FROM THE DISTRICT:** It is the **member's** responsibility to notify the DFT Office when you separate from the district, whether resignation, retirement or termination.
