- Design and execute a robust digital organizing plan to mobilize volunteers and voters for all state legislative races.
- Perform training for local leaders and campaign staff developing training materials on key digital skills like email organizing, social media, and online fundraising.
- Manage other digital staff.
- Other tasks as assigned by the Executive Director.
