- February 13, 2025 (Thursday) **NOMINATIONS CLOSE:** Nominations and acceptance presented to the Election Committee. List of updated nominees compiled with any additional nomination(s) that were accepted from the floor read during the follow-up Election Committee Report by the close of the DFT General Membership Meeting. Nominations will be declared closed as the last order of business.
- February 17, 2025 (Monday) **Eligible Candidates List:** List of eligible candidates emailed and posted on the DFT website.
- February 27, 2025 (Thursday) **DEADLINE FOR FILING GRIEVANCES REGARDING NOMINATIONS:** Emailed to the Election Committee at dft231ec@gmail.com by 5:00 p.m. EST by February 27, 2025. **NO EXCEPTIONS**
- March 3, 2025 (Monday) **ELECTION COMMITTEE** hears grievance(s), if any in the first floor conference room at 5:00 p.m. EST at the DFT Building..
- March 6, 2025 (Thursday) **EXECUTIVE BOARD** hears grievance appeals from Election Committee decision(s), if any in the first conference room at the DFT office.

- March 13, 2025 (Thursday) **MEMBERSHIP MEETING** Membership hears grievance appeal(s), if any at beginning of Membership Meeting and votes on decision(s). Voting begins immediately thereafter.
